I am directed to state that the Postgraduate Medical Education Committee of this Council at its meeting held on 12.06.2018 considered the Compliance Verification Assessment (05/10/2017) along with the Council Assessor's Report (April, 2016 & 03.03.2017) and compliance dated 15/03/2018 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD/MS(OBG) qualification against increased intake from 02 to 03 seats at Government Medical College, Bhavnagar granted by Maharaja Krishnakumarsinghji Bhavnagar University, Bhavnagar. The Committee decided as under:-

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment (05/10/2017) along with the Council Assessor's Report (April, 2016 & 03.03.2017) and compliance dated 15/03/2018 submitted by the college authorities and decided to recommend to the Central Government that MD/MS(OBG) qualification against increased intake from 02 to 03 seats granted by Maharaja Krishnakumarsinghji Bhavnagar University, Bhavnagar in respect of students being trained at Government Medical College, Bhavnagar be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.
