"The Board of Governors considered the Compliance submitted by the college authorities vide letter dated 09.10.2018 along with the previous assessment report (26.03.2018 (for degree) and 27.03.2018 (for diploma) together with the recommendations of the PG Expert Group (BoG) and decided to recommend to the Central Government that the recognition of MS(OBG) qualification for 02 seats and DGO qualification for 01 seat granted by Maharaja Krishnakumarsinghji Bhavnagar University, Bhavnagar in respect of students being trained at Government Medical College, Bhavnagar be renewed.

The Board of Governors further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
